IMPLEMENTING GUIDELINES ON THE CONDUCT OF THE MENTORS DIVISION QUARTERLY/DISTRICT MONTHLY CIRCLE MEETINGS OF THE NATIONAL ENGLISH PROFICIENCY PROGRAM (NEPP)

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Heads, Public Elementary and Secondary Schools

- 1. Pursuant to DepED Memorandum No. 400, s. 2007 entitled "Sustaining National English Proficiency Program (NEPP) Mentoring in Elementary and Secondary Schools Through Division Quarterly/District Monthly Circle Meetings", the following Implementing Guidelines are hereby issued on the conduct of the said meetings:
  - a. The holding of Division Quarterly/District Monthly Circle Meetings will be initiated by the National English Proficiency Program (NEPP) Coordinator. A copy of the year's quarterly schedule will be furnished the Bureau of Elementary Education (BEE) or Bureau of Secondary Education (BSE) through NEPP;
  - b. The Division Quarterly/District Monthly Circle Meetings will be led by a team of 5 composed of the following:

One (1) NEPP Representative

One (1) BEE Representative

One (1) BSE Representative

One (1) NEPP Coordinator - BEE

One (1) NEPP Coordinator - BSE

- c. They will conduct Enrichment Session based on the subject/topic requirements by the Mentoring Program.
- 2. The suggested, activities, contents and purpose of the Circle Meetings are as follows:
  - a. to continue the professional growth of the concerned teachers through <u>demonstration lesson</u>, <u>inputs from invited guests</u> from any of the above team, NEPP-Central Office or Division and Regional Supervisors;
  - b. give time to share best practices;
  - c. address issues and concerns in relation to mentoring and teaching; and
  - d. create an environment which fosters solidarity in the common aim to raise standards of teaching/learning.

- 3. For the conduct of the Quarterly/District or Division Circle Meeting a reimbursement expense of not more than Thirty Thousand Pesos (PhP30,000.00) will be charged against NEPP-OSEC Funds. All concerned are requested to send the Official Receipts (ORs) and Attendance Sheets to NEPP c/o Mr. Rodolfo E. Yaba.
