NATIONAL ACCREDITATION COURSE FOR DEPED SCHOOL SPORTS OFFICIATING OFFICIALS FOR LUZON CLUSTER

To: Undersecretaries **Assistant Secretaries** Bureau and Regional Directors Heads of Private Schools and Universities Schools Division Superintendents

- The Department of Education through the Task Force on School Sports (TFSS) shall conduct the National Accreditation of DepED Sports Officiating Officials for Luzon Cluster on December 2-5, 2007 at the Teachers Camp. Baguio City.
- The accreditation course aims to accredit qualified school sports officiating officials to officiate in school sports competitions while at the same time update them on the latest trends, rules and regulations in their respective sports disciplines; and upgrade their competence as sports officiating officials in managing and officiating in school sports competitions.
- A review on the new rules shall be followed by a written and practical examinations, and physical fitness test.
- Participation is open to school teachers and DepEd personnel who wish to be accredited as officiating officials for the DepEd school sports competitions, provided they meet the following requirements:
 - 5.1 must be physically and mentally fit;
 - 5.2 must possess knowledge and skills in their respective fields of sports disciplines; and
 - 5.3 must have officiated at least in the Division meets for the past 3: years.
- A registration fee of Four Thousand Two Hundred Pesos (Php4,200.00) shall be charged each participant to cover board and lodging, training kit, extra duty allowance of training staff, and other related expenses. Registration fee, transportation, per diem and other incidental expenses to be incurred by the

participants shall be charged against local funds, while board and lodging, transportation, per idem, of training staff and resource persons, honoraria of resource persons, and other incidental expenses shall be charged against A.II.d.1 funds.

- 7. Participants must submit the following documents upon registration:
 - 7.1 Medical certification that participant is fit to undergo strenuous activities, issued by a government physician,
 - 7.2 Certification that participant has officiated in DepEd Athletic Meets for the last three (3) years, to be issued by the Regional PESS Division/Regional Task Force on School Sports
