## NATIONAL ACCREDITATION COURSE FOR DEPED SCHOOL SPORTS OFFICIATING OFFICIALS FOR VISAYAS CLUSTER

- 1. The Department of Education through the Task Force on School Sports (TFSS) shall conduct the National Accreditation Course for DepED School Sports Officiating Officials for Visayas Cluster on February 4-8, 2008 in Cebu City. Registration shall be at the ECOTECH, Lahug, Cebu City.
- 2. The aims of the accreditation course are to: a) accredit qualified school sports officiating officials to officiate in school sports competitions while at the same time update them on the latest trends, rules and regulations in their respective sports disciplines; and b) upgrade their competence as sports officiating officials in managing and officiating in school sports competitions.
- 3. A review on the rules of the different sports disciplines shall be followed by a written and practical examinations, and physical fitness test.
- 4. Participation is open to school teachers and DepED personnel who wish to be accredited as officiating officials for the DepED school sports competitions, provided they meet the following requirements:
  - a. must be physically and mentally fit;
  - b. must possess knowledge and skills in their respective fields of sports disciplines; and
  - c. must have officiated at least in the Division meets for the past 3 years.

Teachers and DepED personnel from Luzon and Mindanao may attend this accreditation course.

5. A registration fee of Three Thousand Five Hundred Pesos (PhP3,500.00) shall be charged each live-in participant to cover board and lodging, training kit, extra duty allowance of training staff, and other related expenses, while Two Thousand Pesos (PhP2,000.00) will be charged each live-out participant to cover

meals (two snacks and lunch), training kit and other related expenses. Registration fees, transportation, per diem and other incidental expenses to be incurred by the participants shall be charged against local funds, while board and lodging, transportation, per diem of training staff and resource persons, honoraria of resource persons, and other incidental expenses shall be charged against A.II.d.1 funds.

- 6. Participants must submit the following documents upon registration:
  - a. Medical certification that the participant is fit to undergo strenuous activities, to be issued by a government physician; and
  - b. Certification that the participant has officiated in DepED Athletic Meets for the last three (3) years, to be issued by the Regional PESS Division/Regional Task Force on School Sports.
