HOUSING FAIR FOR PUBLIC SCHOOL TEACHERS AND NON-TEACHING EMPLOYEES

- 1. The Housing and Urban Development Coordinating Council (HUDCC) in coordination with the Department of Education Task Force on Teachers and Personnel Housing Program and government shelter agencies such as HDMF-Pag-ibig Fund, GSIS, SSS, etc., is holding a Housing Fair for Public School Teachers and Non-teaching Personnel.
- 2. The Housing Fair aims to assist public school teachers and non-teaching personnel of DepED to acquire housing units at affordable terms and conditions as well as to fast track the disposal of eligible acquired assets of key shelter agencies and government financial institutions. During the Fair, interested participants with existing Pag-Ibig Fund and GSIS housing loans will be allowed to purchase one or more acquired properties subject to the guidelines of the agency/owner.
- 3. The activities during the Housing Fair include the presentation of properties of key shelter agencies and government agencies, speak-ups on the mechanics of the disposition of acquired assets and their existing housing programs, and product presentation of participating developers. There will also be a Housing Clinic wherein participants can also air their problems/grievances related to housing.
- 4. Following the successful launching of the Housing Fair at the Bulwagan ng Karunungan, DepED Central Office, Meralco Avenue, Pasig City last February 13-15, 2008, housing fairs will be conducted in the different regions to extend the benefit to the teaching and non-teaching personnel in the field offices. The schedule of the regional housing fairs will be announced later.
- 5. Regional Directors are directed to coordinate with the heads of the Regional HUDCC offices regarding the different preparatory activities, requirements and details for the conduct of the housing fair.
- 6. Public school teachers and non-teaching personnel are authorized to participate in the Housing Fair on official time.

- 7. Expenses that will be incurred by the regional office relative to the Housing Fair shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
