## 2008 METROBANK-MTAP-DEPED MATH CHALLENGE NATIONAL FINALS AND AWARDING CEREMONY

- 1. The Metrobank Foundation, Inc. (MBFI), the Mathematics Teachers Association of the Philippines (MTAP), and the Department of Education (DepED) announce the 2008 Metrobank-MTAP-DepED Math Challenge National Finals and Awarding Ceremony on April 4-5, 2008.

(02) 891-7874, (02) 834-5594 or (02) 702-2700. Participants are expected to be at the hotel **before noon on April 4, 2008**. The concerned Metrobank Branches shall make the travel arrangements.
- 4. Travel, accommodation and meal expenses of all contestants and individual/team coaches will be shouldered by MBFI.
