

**ENHANCEMENT TRAINING OF TRAINERS ON ASSESSING BEGINNING READING
FOR REGIONAL TRAINERS IN GRADES I-III**

To: Bureau Directors
Regional Directors

Heads, Public Elementary Schools

1. The Department of Education (DepED) through the National English Proficiency Program (NEPP) in coordination with the Bureau of Elementary Education (BEE) will conduct the Enhancement Training of Trainers on Assessing Beginning Reading for Regional Trainers in Grades I-III on April 21-26, 2008 at Girl Scout of the Philippines (GSP), Tagaytay City.
2. The training aims to:
 - a. update the NEPP regional trainers on the best practices employed by the region;
 - b. enhance them on their knowledge and skills on Communicative Language Teaching (CLT);
 - c. deepen their understanding on assessing beginning reading; and
 - d. prepare a training proposal for the conduct of a nationwide enhancement training of teachers.
3. Participants to this activity are the NEPP regional coordinators and NEPP regional trainers in Grades I-III, in the sixteen (16) regions. Please refer to the enclosure for the number of participants per region.
4. The training is for free. Expenses for this activity such as board and lodging, conference kit with handouts/supplies and materials, transportation expenses, honoraria of resource persons, extra duty allowance of management and staff and other incidental expenses shall be charged against NEPP funds subject to the usual accounting and auditing rules and regulations.
6. Transportation expenses of the participants will be reimbursed from NEPP funds upon submission of travel documents. The participants are advised to take the cheapest mode of transportation. They are also expected to arrive at the venue **after lunch** of April 21 and leave after lunch of April 26, 2008.
