**6<sup>TH</sup> STAFF DEVELOPMENT SEMINAR OF THE DEPARTMENT OF EDUCATION  
NATIONAL NURSES ASSOCIATION (DENNA)**

1. The Department of Education National Nurses Association (DENNA) will hold its 5<sup>th</sup> Staff Development Seminar on May 31 to June 2, 2008 at Teachers' Camp, Baguio City with the theme "Quality School Nursing in a Rapid Changing World"
2. The objectives of the seminar are to:
  - a. enhance the school nurses' knowledge, skills and attitude (KSA) on resource mobilization and program management for an effective and efficient provision of health services during the intervention phase of the Expanded Universal Medical Dental Check up (E-UMDC);
  - b. deepen the school nurses' awareness on occupational and health hazards confronting them in the school setting; and
  - c. revisit and enrich individual's commitment while strengthening teamwork and collaboration in planning and organizing future programs/projects for the school children in a rapid changing environment.
3. The participants to the seminar are the school nurses from the DepED Central Office, regional and division offices and those from the public and private schools. Registration of participants commences on May 31, 2008 at 5:00 pm. Check out time will be on June 2, 2008 after breakfast.
4. Considering the technical benefits that can be gained from the activity, the school nurses shall be allowed to attend on official business. Transportation and other expenses of the participants, including a registration fee of three thousand pesos (P3,000.00) for the board and lodging, kits, certificate and other incidental expenses shall be chargeable against local funds, subject to the usual accounting and auditing rules and regulations. Expenses may also be sourced out from the school board fund and local NGO's. Participants from private schools shall make arrangement with their respective schools relative to their attendance.
