**THE ART OF COACHING: A NATIONAL TRAINING-SEMINAR
FOR DEPED SCHOOL SPORTS COACHES/TRAINERS**

To: Undersecretaries
Assistant Secretaries
Bureau and Regional Directors
Heads of Private Schools and Universities
Schools Division Superintendents

1. The Task Force on School Sports (TFSS) of the Department of Education shall conduct a two-cluster training-seminar in **The Art of Coaching: A National Training-Seminar for DepED School Sports Coaches/Trainers** on the following dates and venues:

- 1.1 Visayas and Mindanao Cluster – June 23-27, 2008 Pelaez Complex, Cagayan de Oro City
- 1.2 Luzon Cluster – July 14-18, 2008 Teachers Camp, Baguio City

2. The training aims to: a) understand the opportunities of coaching; b) define the roles and responsibilities of coaches; c) enhance the skills of teacher coaches/trainers in coaching, conditioning and training athletes in archery, arnis, athletics, badminton, baseball, basketball, boxing, chess, football, gymnastics, sipa/sepak takraw, softball, swimming, taekwondo, table tennis, tennis, and volleyball.

3. Participants shall be teachers, coaches, trainers who meet the following requirements:

- 3.1 must be physically and mentally fit; and
- 3.2 must possess knowledge and skills in their respective sports.

4. A registration fee of **Four Thousand Five Hundred Pesos (Php4,500.00)** for Luzon Cluster and **Three Thousand Four Hundred Pesos (Php3,400.00)** for Visayas and Mindanao Cluster shall be charged each participant to cover board and lodging, training kit, transportation of participants going to and from the training venue, extra duty allowance of training staff, and other related expenses. Registration fee, transportation, per diem and other incidental expenses to be incurred by the participants shall be charged against local funds, while board and lodging, transportation, per idem, of training staff and resource persons, honoraria of resource persons, and other incidental expenses shall be charged against A.II.d.1 funds.
