ADOPTION OF THE IMPLEMENTATION OF THE PROJECT: INSTRUCTIONAL  
MANAGEMENT BY PARENTS, COMMUNITY AND TEACHERS (E-IMPACT)

To: Bureau Directors  
Regional Directors  
Schools Division/City Superintendents  
Heads, Public Elementary Schools

1. The Instructional Management by Parents, Community and Teachers (E-IMPACT) is a system of education being implemented in some schools in the country. It is a radical departure from the conventional system of education. It has been found to be effective in depressed, disadvantaged and underserved areas especially in multigrade schools. This is a project conceptualized and developed by SEAMEO-INNOTECH with the cooperation of the Department of Education.
2. Under the current CPC-6, through the Child-Friendly School System being funded by UNICEF, E-IMPACT will be adopted in 19 more schools all over the country since this approach adheres to the principles and framework of CFSS and strongly emphasizes children and community participation in school affairs. (See enclosed list of schools).
3. Initial trainings were conducted by INNOTECH in collaboration with UNICEF in Cebu and Davao. These trainings were focused on the instructional delivery mechanisms and on preparing the teachers for their roles as instructional supervisors. This year, a follow up segment which will focus on enhancing the teachers' skills in developing and measuring higher order thinking skills will be held at Lantaka Hotel, Zamboanga City on May 12-16, 2008.
4. Participants to this 5-day training-workshop are two (2) teachers each from the 19 pilot schools. Travel expenses and DSA of the participants shall be charged against their Provincial Annual Work Plan while travel expenses and DSA of all resource persons shall be charged against the National Annual Work Plan. Board and lodging, supplies and professional fee of the resource persons will also be charged against the National Annual Work Plan to be managed by INNOTECH subject to the usual accounting and auditing rules and regulations. 5. District Supervisors and Division and Regional Coordinators will have a subsequent training sometime in August on mentoring. This training will be funded by DepED-BEE Fund.
