## ORIENTATION-WORKSHOP FOR REGIONAL AND DIVISION OFFICIALS ON THE STRENGTHENED TECHNICAL-VOCATIONAL EDUCATION PROGRAM

- 1. Effective SY 2008-2009, a total of 261 tech-voc high schools shall be covered by the Strengthened Technical-Vocational Education Program (STVEP).
- 2. For the effective implementation of the program, an orientation-workshop for the Regional and Division Officials shall be conducted on June 17-19, 2008 at Development Academy of the Philippines (DAP) in Tagaytay City.
- 3. The objectives of this Orientation-Workshop are to:
  - a. orient the Regional and Division officials on the background and objectives of the STVEP;
  - b. update them on the accomplishments and next steps of the program;
  - update them on the arising policies regarding the STVEP program;
  - d. gather issues and concerns as well as feedbacks on the implementation of STVEP at local levels and recommend possible solutions for said matters;
  - e. formulate a supervisory and monitoring plan for tech-voc high schools under their jurisdictions; and
  - f. disseminate information effectively to the field.
- 4. Participants to the workshop are the following:
  - a. Schools Division/City Superintendents;
  - b. Regional TLE/TVE Supervisors/TVE Coordinators;
  - c. Division TLE/TVE Supervisors (only those divisions with techvoc high schools); and
  - d. Secondary Division Chiefs
- 5. Participants shall be provided with the Annual Implementation Plan (AIP) and School Improvement Plan (SIP) prepared by the 261 TVHS Heads.

- 7. Board and lodging expenses, extra duty allowance of the secretariat and honoraria of the resource speakers shall be charged against HRTD funds, while transportation expenses of the participants shall be charged against local funds subject to the usual government accounting and auditing rules and regulations.
