2008 NATIONAL SEARCH FOR THE MOST OUTSTANDING ALS MOBILE TEACHER AND DISTRICT ALS COORDINATOR

- 1. The Department of Education (DepED), through the Bureau of Alternative Learning System (BALS) announces the 2008 National Search for the Most Outstanding ALS Mobile Teacher (MT) and District ALS Coordinator (DALSC).
- 2. The search aims to promote local knowledge and develop ingenuity among alternative learning system implementers, particularly the Mobile Teachers and the District ALS Coordinators. This is one of the activities under the Project "Usapan at Aksiyon sa ALS Ngayon" (USAPAN) that seeks to support the professional growth and development of the ALS Mobile Teachers/District ALS Coordinators.
- 3. The search also seeks to give due recognition to the ALS Mobile Teacher and District ALS Coordinator as a noble profession by recognizing his/her exemplary performance, dedication and outstanding achievements in the promotion of literacy and ALS among the deprived, depressed and underserved populace.
- 4. The search is open to all the ALS Mobile Teachers and full-time District ALS Coordinators nationwide.
- 5. Enclosed is a copy of the Guidelines for the Search. All entries must reach the BALS Search Committee on or before August 30, 2008.
- 6. All expenses relative to the conduct of the abovementioned activities are chargeable against BALS Funds subject to the usual government accounting and auditing rules and regulations.

Guidelines on the Search for Most Outstanding ALS Mobile Teachers and District ALS Coordinators

I. General

- 1. The Search is open to all ALS Mobile Teachers and Full-time District ALS Coordinators nationwide.
- 2. The Search will be conducted at the national level. However, only nominations by the Schools Division Superintendent based on the Recommendation of the Division ALS Supervisor, District Supervisor and the Principal/School Head incharge of the ALS Mobile Teacher and the District ALS Coordinator will be considered. All Nomination Forms with supporting documents must be submitted to the Regional Director, Attention the ALSD Chief on or before August 20, 2008.
- 3. The Search is divided into two categories: a) the ALS Mobile Teacher category and b) the District ALS Coordinator category.
- 4. Any nomination must be accompanied by a duly accomplished Nomination Form (Annex 1).
- 5. All nominations with corresponding support documents endorsed by the DepED Regional Director must be forwarded and addressed to:

6. Deadline for submission of nomination is on August 30, 2008. All nominations must reach the BALS on this date

II. Evaluation of Entries and Criteria for Judging

- 1. The Search nominations will be evaluated based on the following criteria:
 - Potential A. - 40% (Personality and Character - 10%, Job

Competence - 20%, and Professional

Growth - 10%)

- Achievements 60% (Work Achievements 20%, Impact on the B. Learners - 20%, and Community Development - 20%)
- 2. There will be separate evaluation for the two search categories (MT and DALSC).
- 3. Evaluation and judging at the national level will involve three (3) phases, namely:
 - First Round a panel of evaluators composed of selected BALS technical A. staff will determine which entries go to the second round of evaluation as finalists. Ten (10) entries will be selected as semi-finalists.
 - Second Round a panel of evaluators composed of BALS technical staff B. will evaluate the 10 semi-finalists to determine the five (5) finalists.

- C. Third Round a panel of evaluators composed of a chairperson and three (3) members will be tasked to analyze the pertinent records, on-site observations of and interviews with the nominees, learners and other concerned stakeholders (e.g. residents of the community served, LGU, key DepED officials and significant others)
- After thorough deliberations, the first, second and third place national winners will be drawn. The
 decision of the Panel of Evaluators is final and executory.
- 5. The winners and the schedule of awarding will be announced formally through a DepED Memorandum.

III. Awards and Prizes

- Winners will receive prizes in form of cash and plaque/certificate of recognition for each category.
- 2. Prizes will be as follows for each category:

• First Prize - P 50,000.00

NATIONAL SELECTION PROCESS

- Step 1 Preliminary Board of Judges shall be organized composed of not more than five (5) members each category from the BALS technical staff. Final Board of Judges shall be organized also composed of not more than three (3) external members per category.
- Step 2 Preliminary Board of Judges shall review the entries and shortlist or select the top five (5) nominees for each category from which the final winners shall be chosen.
- Step 3 Preliminary Board of Judges shall meet to discuss the strong and weak points of shortlisted nominees.
- Step 4 Final Board of Judges shall conduct on-site validation of selected nominees for further verifications. Interviews with nominees/finalists, local officials, beneficiaries, community members, etc. shall likewise be conducted.

Final Board of Judges shall choose the three (3) best nominees based on their findings during visitations as final top three (3): 1st, 2nd and 3rd, and two (2) consolation winners per category and endorse the recommendation to the BALS.

Step 5 - BALS shall declare and award the winners
