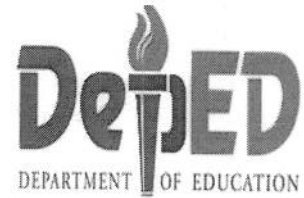

SEMINAR-WORKSHOP ON CREATIVE PROBLEM INTERVENTION FOR SCHOOL ADMINISTRATORS AT THE FIELD LEVEL

To: Regional Directors

1. The Office of the Undersecretary for Legal Affairs will conduct a follow-up Seminar-Workshop on Creative Problem Intervention for School Administrators at the Field Level from July 2 to August 31, 2008 nationwide by cluster.

3. The seminar aims to update and heighten the creative capability of the target participants on the legal, policy and practical aspects of problem intervention (intervention and solving) at their jurisdictions.

Participants for each cluster are Regional Directors, Assistant Directors, School Division/City Superintendents, Division Supervisors, Legal Officers and Administrative Officers who **failed to attend the previous seminars**. Likewise, selected school principals shall be encouraged to participate. All participants are also encouraged to check-in a day before the seminar. Dinner will be served on this day.
5. Board and lodging of participants, honoraria of speakers, extra-duty allowance of organizers, facilitators and staff, handouts/materials and other incidental expenses will be borne by OSEC funds, while the traveling expenses of the participants will be charged to local funds subject to the usual accounting and auditing rules and regulations.
