 CONFERENCE AND WORKSHOP

1. Pursuant to DepED Order No. 73, s. 2003 on Strengthening the Student Technologists and Entrepreneurs of the Philippines (STEP) to Enhance the Technology and Livelihood Education (TLE) of the Basic Education Curriculum (BEC) and DepED Order No. 55, s. 2002 on the Revitalized Youth Entrepreneurship and Cooperativism in Schools (YECS) Program and DepED Order No. 56, s. 2005 on the Revised Implementing Guidelines on the Operation of the Youth Entrepreneurship and Cooperativism in Schools Program, the Department of Education-Center for Students and Co-Curricular Affairs (DepED-CSCA) will conduct the YECS and STEP Annual Evaluation and Planning Conference and Workshop on Various Contest Packages on July 1-6, 2008 at the Marikina Hotel, Marikina City.

2. The YECS and STEP Annual Evaluation and Planning Conference and Workshop aims to achieve the following objectives:

- a. Evaluate the YECS and STEP programs, including the conduct of the 6th STEP-National Skills Development and Competition (NSDC) held last November 19-24, 2007 in Davao City;
- b. Identify and resolve issues and concerns pertinent to the YECS and STEP implementation;
- c. Update YECS and STEP vis-à-vis the refined Technology and Livelihood Education Curriculum and Technical-Vocational Education;
- d. Plan for the conduct of the 7th STEP-NSDC;
- e. Craft/Codify rules, regulations and guidelines in the conduct of skills competitions;
- f. Craft and finalize new contest packages for the elementary, secondary and technical-vocational levels;
- g. Review and update the STEP Constitution and By-Laws; and,
- h. Prepare for the 2008 Teen Negosyo.

3. Participants to this conference are Technology and Livelihood Education (TLE) Regional Supervisors/YECS and STEP Regional Coordinators, Edukasyong Pantahanan at Pangkabuhayan (EPP) Regional Supervisors/Coordinators, Technical-Vocational Education (TVE) Regional Coordinators, selected officers of the STEP National Board of Advisers Organization (NBAO), representatives from the Bureau of Secondary Education (BSE), Bureau of Elementary Education (BEE) and Tech-Voc Task Force, invited experts and writers, and staff of the Center for Students and Co-Curricular Affairs.

4. Participants are expected to be at the venue before 12:00 nn on July 1, 2008. The CSCA shall only shoulder board and lodging beginning lunch on July 1, 2008 until breakfast on July 6, 2008.
5. Travel expenses and other incidental expenses of participants shall be charged against local funds subject to the availability of funds and the usual accounting and auditing rules and regulations. Expenses for food and accommodation, supplies and materials and other incidental and necessary allowances and expenses shall be shouldered by the DepED-CSCA.
