WORKSHOP ON THE STANDARDIZED ADMINISTRATION OF THE SY 2008-2009
NATIONAL CAREER ASSESSMENT EXAMINATION (NCAE) FOR FOURTH
YEAR HIGH SCHOOL STUDENTS

- 1. The National Education Testing and Research Center (NETRC) shall conduct a Workshop on the Standardized Administration of the National Career Assessment Examination (NCAE) for Fourth Year High School students in SY 2008-2009.
- 2. The National Career Assessment Examination (NCAE) for Fourth Year High School students shall be administered both in public and private schools on August 27, 2008.
- 3. The following shall be discussed in the workshop:
 - Proper conduct/administration of the test;
 - Security of test materials, delivery and retrieval scheme:
 - Allocation of test materials:
 - Information derived from and interpretation of the Individual Certificate of Rating; and
 - Financial issues relative to test administration such as the mode of transfer and utilization of financial requirements.
- 4. Authorized to attend are Regional Testing Coordinators (RTCs) and Division Testing Coordinators (DTCs).
- 5. DTCs are instructed to bring the actual enrollment of Fourth Year High School students (SY 2008-2009), both public and private schools in hard and soft (CD) copies.
- 6. The dates of the said workshop are as follows:
