

1. The Consumer Education Exemplar in all areas of learning (English, Filipino, Science, Mathematics, Social Studies, Values Education, MAPEH, and TLE) is now ready for Validation and Finalization. These exemplars will be utilized beginning SY 2009-2010.
2. A five-day live in writeshop on the validation and finalization of the said instructional exemplar shall be held at the Loreland Farms, Barangay San Roque, Antipolo City on June 29-July 4, 2008.

The writers/validators in this writeshop are from the different regions and Bureau of Secondary Education (BSE), resource persons from the Department of Trade and Industry (DTI), encoders, editors, facilitators, and technical staffs. Writers/Validators are requested to bring their own laptops. Participants are hereby enjoined to strictly adhere with the official list of participants (enclosed).

Board and lodging, writeshop kits and tokens of the participants, transportation and per diem and other expenses of the DTI representatives shall be charged to DTI local funds while the preparatory expenses, documentation and communication, extra-duty allowance of the consultants, TWG, facilitators, encoders, secretariat and honoraria of the writers and speakers, transportation and per diem of the writers, secretariat and TWG shall be charged to OSEC funds subject to the usual accounting and auditing rules and regulations.
