CORRIGENDUM AND ADDENDUM TO DEPED MEMORANDUM NO. 162, S. 2008 ("Tulong Barya Para sa Eskwela: Part II" Campaign)

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Elementary and Secondary Schools

- 1. Paragraph 4 of DepED Memorandum No. 162, s. 2008 is hereby changed to read as follows:
 - 4. The coin collection and recirculation campaign shall run from July 7 to December 31, 2008. All public schools are encouraged to support and participate in the said campaign. Nevertheless, the campaign is open to all who would like to join such as private schools, colleges, universities, business establishments, and government agencies. Collections from participants in this campaign aside from public schools are considered donation to DepED.
- 2. The following statements have been added to DepED Memorandum No. 162, s. 2008:
 - 1. The "Tulong Barya Para sa Eskwela Part II" coin collection and recirculation campaign shall be launched simultaneously in all public elementary and secondary schools nationwide on July 7, 2008.
 - 2. In line with this, all schools are enjoined to conduct a short program on the launching during the flag raising ceremony.
 - 3. To properly account the coins collected and deposited, all participating schools should accomplish the enclosed forms and submit these to their respective Adopt-a-School Program (ASP) Division Coordinators. ASP Division Coordinators are expected to consolidate these reports and submit these to the Regional Office c/o ASP Regional Coordinator.
 - 4. The reports that will be submitted by the Regional Offices to the Central Office shall be the basis for the incentives system that will be granted at the end of the campaign.
