WRITESHOP ON THE REFINEMENT OF SCIENCE LABORATORY MANUALS AND TEACHER'S GUIDES FOR REGIONAL SCIENCE HIGH SCHOOLS

To: Regional Directors
Schools Division/City Superintendents
Heads, Regional Science High Schools

- 1. The Bureau of Secondary Education (BSE), through the Curriculum Development Division (CDD) shall conduct the **Writeshop on the Refinement of Science Laboratory Manuals and Teacher's Guides for the Regional Science High Schools (RSHSs)** on September 14-20, 2008, inclusive of travel time, at Ecotech Convention Center, Lahug, Cebu City.
- 2. The activity aims to finalize the science laboratory manuals as well as the teacher's guides in Science I to IV. This is in preparation for teachers' training on safety measures in handling and using equipment and chemicals in the laboratories.
- 3. The participants in this activity are the nominated RSHSs Science teachers (see enclosure) in the following subjects:
 - a. Integrated Science or Earth/Environmental Science
 - b. Biology or Botany or Zoology
 - c. Chemistry or Advanced Chemistry
 - d. Physics or Advanced Physics
- 4. Science teacher participants may swap their time schedules with other teachers in the schools to avoid disruption of classes. They can then offset their absence in class with the same number of class hours upon their return from the writeshop.
- 5. Teacher participants are requested to bring their laptops and printers, textbooks/teachers' guides and other references in their respective subjects.
- 6. Registration starts on September 14, 2008 upon arrival and first meal (dinner) will be served on the same day. Opening program shall be at 8:00 a.m. on September 15, 2008.
- 7. Travel expenses of participants from their official station to the venue of the writeshop shall be charged against local funds, whereas travel expenses, per diems and other incidental expenses of BSE staff and consultants, honoraria of consultants and teacher writers, board and lodging of BSE staff, consultants, regional participants, supplies/materials shall be charged against OSEC Funds (Operational Expenses for RSHSs), subject to its availability and the usual accounting and auditing rules and regulations.
