DepED MEMORANDUM No. 368, s. 2008

EDUCATION, TRAINING AND INFORMATION PROGRAM FOR COOPERATIVES

To: Regional Directors
Schools Division/City Superintendents
Heads, Public Elementary and Secondary Schools
All Others Concerned

- 1. The Philippine Federation of Teachers and Employees' Cooperatives (PFTEC), an umbrella organization of duly registered teachers' cooperatives and in cognizance of its complementary role in strengthening the registered teachers and employees' cooperatives in DepED, announces the schedule of its annual education, training and information program.
- 2. The program is intended to provide the needed cooperative education, training and information to elected cooperative leaders and officers, cooperative managers and staff. Its general purpose is to prepare the registered teachers' cooperatives to adhere to the Manual of Rules and Regulations (MORR) through mentoring, supervision and regulations provided by cooperative federations, such as PFTEC. Specific training courses are designed to professionalize elected officers that will empower the teachers' cooperatives as an emerging sector in the fight to improve the quality of life through cooperativism.
- 3. Enclosed are the annual education, training and information program, schedule of activities and enrollment form.
- 4. Participants to the PFTEC training programs are cooperative officials, managers and staff. School officials are enjoined to allow the officers of duly registered teachers' cooperatives to participate in the training programs, on official time only, pursuant to Chapter III, Article 28 of RA 6938.
- 5. The cost of registration fees, travel and other related expenses in attending the training programs shall be chargeable against the allocation for the "Due to Cooperative Education and Training Fund (CETF) Local" of the respective registered teachers' cooperative. Expenses relative to participation in the PFTEC training programs shall not be chargeable against the funds of the Department of Education.
