DEBRIEFING AND EVALUATION OF THE REGIONAL CONDUCT OF THE NEPP PHASES III AND IV, AND PLANNING FOR THE CONDUCT OF ENHANCEMENT OF TRAINERS OF GRADES I-III AND THE SECOND NATIONAL ASSOCIATION OF MENTORS IN EDUCATION CONFERENCE

- 1. The National English Proficiency Program (NEPP) will conduct a **Debriefing and Evaluation of the Regional Conduct of the NEPP Phases III and IV and Planning for the Conduct of the Enhancement of Trainers of Grades I-III and the Second National Association of Mentors in Education Conference** on August 27-29-, 2008 at Girl Scouts of the Philippines, Tagaytay City.
- 2. The objectives of the activities are to:
 - a. give feedback on the conduct of Phases III and IV trainings;
 - b. evaluate the outcomes of said regional trainings; and
 - c. plan for the conduct of the following:
 - 1. Five-day Enhancement Training for the First Batch of Grades I-III teachers trained last summer 2007;
 - 2. Teachers' Post Assessment; and
 - 3. The Second National Association of Mentors in Education Conference.
- 3. The participants to this activity are the Chiefs or Assistant Chiefs or Officer-in-Charge (OIC) of the Elementary Education Division (EED) in the region, the NEPP Regional Coordinators of the seventeen (17) regions who conducted the regional trainings last May, June, July and August 2008 and National Trainers and Consultants and NEPP Management and Staff.
- 4. Transportation allowance, board and lodging, honoraria, supplies and materials and other expenses shall be charged against OSEC-NEPP funds subject to the usual accounting and auditing rules and regulations.
