DepED MEMORANDUM No. 437, s. 2008

CREATION OF A COMMITTEE TO SELECT THE DEPED UNIFORM FOR SY 2009-2010 AND 2010-2011

- 1. In order to facilitate the selection of uniform for officials and employees of the Department of Education, a Uniform Committee is hereby created to select the DepED uniform for SY 2009-2010 and 2010-2011.
- 2. The Committee shall be composed of representatives of all the sectoral groups in the Department, i.e. regional directors, bureau/service/center directors, schools superintendents, education supervisors, district supervisors, school heads/principals, teachers and the non-teaching employees.
- 3. The Uniform Committee shall be tasked to:
 - a. prepare the guidelines for the selection process which will include the specifications as to what type of uniform will be most appropriate and suitable for the teachers and nonteaching employees;
 - decide on issues such as having a centralized uniform, or a national uniform, a regional uniform, a division uniform and school uniform and the days when these uniforms will be worn (for teachers and employees in the regional and division offices and schools); and
 - c. determine the mode of distributing the clothing allowance for CY 2009 and the method of procuring the clothing materials for the selected uniforms.
- 4. The uniform designs that will be selected by the Committee, as well as the mode of distributing the clothing allowance and the method of procuring the clothing materials, shall be presented to the MANCOM and EXECOM for approval.

5. The Uniform Committee is hereby constituted as follows:
