- 1. To further strengthen the Moral Recovery Program, pursuant to Executive Order No. 314, s. 2004, "Creating the Presidential Commission on Values Formation (PCVE)", the Moral Recovery Officers Foundation, Inc. (MROFI) shall hold its 10th Year Moral Recovery Officers National Convention and General Assembly on November 27-28, 2008 at the Richville Hotel, EDSA, Mandaluyong City, as per Civil Service Commission (CSC) Announcement No. 47, s. 2008.
