1ST NASSPHIL CONGRESS FOR PUBLIC SCHOOL PRINCIPALS
ON RESOURCE MANAGEMENT

1. The National Association of Secondary Schools of the Philippines (NASSPHIL-Public) in collaboration with the DepED - Procurement Service (PS), shall conduct the 1ST NASSPHIL Congress for Public School Principals on Resource Management with the theme "The Principal as an Effective Resource Manager", on February 4-7, 2009 at the Sarabia Manor Hotel and Convention Center, Iloilo City.
2. The congress aims to:
 - a. upgrade the public school principals' knowledge and skills on resource management within the framework of School-Based Management; and
 - b. organize the public school principals of NASSPHIL at the regional level.
3. The participants to this congress are the NASSPHIL officers from public schools, secondary school heads and teachers in-charge. The officers will manage the conference and serve as resource persons for the workshops. Attendance to this conference shall be on official business. Enclosed is the schedule of activities.
4. A registration fee of Four Thousand Five Hundred Pesos (PhP4,500.00) shall be charged each participant to cover board and lodging, training materials and other related conference expenses. Meals shall be served on the dinner of February 4 until breakfast of February 8. Members of the different committees, as well as the present NASSPHIL officers from the public schools and Board of Directors are authorized to travel two (2) days before the conference. Traveling expenses and registration fee shall be charged against local funds or local school board funds, subject its availability and the usual accounting and auditing rules and regulations.
