**NATIONAL FEDERATION OF SUPREME STUDENT GOVERNMENTS  
(NFSSG) CONFERENCE**

To: Regional Directors  
Schools Division/City Superintendents  
School Principals/Heads, Public and Private Secondary Schools

1. The Department of Education-Center for Students and Co-Curricular Affairs (CSCA) will conduct the National Federation of Supreme Student Governments (NFSSG) Conference on February 7-11, 2009 in Bohol.

2. This annual conference aims to achieve the following objectives:

- a. Evaluate the implementation of the Student Government Program (SGP) and the Constitution and By-Laws of the Supreme Student Governments, including the conduct of the 6<sup>th</sup> National Leadership Training for Student Government Officers (NLTSO);
- b. Identify and resolve issues and concerns pertinent to the SGP implementation and the conduct of the 6<sup>th</sup> NLTSO;
- c. Evaluate the implementation of the Thrusts and Activities of the SGP for School Year 2008-2009;
- d. Discuss the implementation of the Peer Counseling Program in Schools and other projects which harness the student government as an effective partner in achieving quality education and academic excellence in schools; and,
- e. Improve efforts in making available real exposure, experience and learning in responsible and participative democracy and leadership.

3. Participants to this evaluation and planning conference (list enclosed) are the Officers of the National Federation of Supreme Student Governments (NFSSG), Araling Panlipunan Regional Supervisors or the Student Government Program Regional Coordinators, Representatives from the Supreme Student Government (SSG) Teacher-Advisers and DepED-CSCA personnel. Participants are expected to be at the venue in time for lunch on February 7, 2009 until breakfast of February 11, 2009.

4. Travel expenses and other incidental expenses of participants, except the officers of the National Federation of Supreme Student Governments, shall be charged against local funds and other sources subject to the usual accounting and auditing rules and regulations. Expenses for board and lodging, supplies and materials shall be shouldered by the DepED-CSCA chargeable against the excess funds generated from the conduct of the 6<sup>th</sup> NLTSO. Transportation expenses of the NFSSG Officers, CSCA Staff and Resource Persons shall be charged against DepED Central Office funds.
