SECOND NASSPHIL NATIONAL CONGRESS

1. The National Association of Secondary Schools of the Philippines (NASSPHIL), Inc., in coordination with the Bureau of Secondary Education (BSE) announces the holding of its **Second National Congress** on May 4-6, 2009 at the Garden Royale, Goldenfield, Bacolod City, with the theme "At the Crossroads of High School and Beyond (The Principal Managing the Path and the Transition)".

2. The congress aims to:

a. envision and understand the nuances of the student alternative paths beyond secondary education;

b. have an appreciation of the critical stages from the entry of the student to high school and the transition from school to work and/or further education; and

c. examine the specific role of each learning area in the curriculum, the institutional interventions in the curriculum, and the elements of the curriculum.

- 3. The participants to this congress are Public and Private School Principals, Assistant Principals, Heads, Officers-in-Charge (OICs), Administrators, and Heads of secondary trade-agriculture-fisheries and teacher members of the NASSPHIL Mother Board. The Chiefs of Secondary Education Division, Supervisors in-charge of public and private schools and the Schools Division Superintendents and Assistant Schools Division Superintendents are invited to attend the congress. Attendance to the congress shall be on **official business**.
- 4. A registration fee of Five Thousand Pesos (PhP5,000.00) per participant, including working committee members, shall be charged to cover board and lodging, materials and other related congress expenses. Meals shall be served from dinner of May 3 until lunch of May 6, 2009. Members of the different committees, as well as the present NASSPHIL officials and Board of Directors are authorized to travel two days before the congress. Traveling expenses and registration fee shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
