ENHANCING EFFICIENCY IN PUBLIC SERVICE DELIVERY (GRAFT AND CORRUPTION PREVENTION EDUCATION)

1. As part of the Department's initiative to maintain honesty and integrity in the delivery of quality education and basic services, the Staff Development Division-Human Resource Development Service (SDD-HRDS) in coordination with the Offices of the DepED Resident Ombudsman will conduct 3 batches of nationwide training involving the regions on the following dates:

VI, VII, VIII and IX	June 23-25, 2009	Within the area of Cebu
I, II, III, and CAR	July 7-9, 2009	Within the area of Subic
X, XI, XII and CARAGA	April 14-16, 2009	Within the area of Davao City

- 2. This program is an anti-corruption campaign which aims to enhance efficiency in the delivery of service in DepED by introducing the department's integrity development program to all non-teaching personnel. It also intends to heighten the awareness and make government employees sensitive and be deeply involved in combating corruption.
- 3. Participants to this training are Levels 1 and 2 non-teaching personnel from the central, regional and division offices. They are expected to be in the venue in the afternoon of Day 0. Those who will be arriving after lunch of Day 1 will not be admitted to the workshop.

- 5. Travel and per diem of participants are chargeable against local funds while board and lodging expenses, travel and per diem of facilitators and resource persons, training kits, supplies, function room rental, honoraria of resource persons, facilitators, project staff and contingency funds are chargeable against HRTD (Human Resources Training and Development), subject to the usual accounting and auditing rules and regulations.
