SUMMER SEMINAR-WORKSHOP OF THE PHILIPPINE ASSOCIATION OF ACADEMIC AND RESEARCH LIBRARIANS (PAARL)

- 1. The Philippine Association of Academic and Research Librarians (PAARL) will hold its three-day Summer Seminar-Workshop from April 29 to May 1, 2009 at the Lyceum of Aparri, Macanaya District, Aparri, Cagayan Valley with the theme "Librarians at their Best: Envisioning and Realizing Multilevel and Progressive Readers Services".
- 2. The objectives of this seminar are to:
  - a. revitalize the participants on the core concepts of Readers Services through optimal use of web-based technologies and integration of multi-channel interaction strategies and approaches to patrons of dynamic cultures and preferences;
  - b. discuss the close association between readers and librarians in creating valuable and productive Readers Services, programs and activities;
  - c. brainstorm, benchmark and draw recommendations that will best sustain and facilitate the exceptional functions and crucial role of Readers Services in shaping the minds and values of library patrons.
- 3. The registration fee is Four Thousand Pesos (PhP4,000.00) for live-in participants inclusive of 3 days/2 nights accommodation with meals and snacks, seminar kits, handouts, cultural tour and certificates. Accompanying persons of live-in participants will be charged Three Thousand Pesos (PhP3,000.00) to cover the cost of accommodation with meals and snacks and cultural tour. For live-out participants who wish to arrange for their own accommodation, seminar fee is Three Thousand Five Hundred Pesos (PhP3,500.00).
