19th ANNUAL CONVENTION OF THE PAMBANSANG SAMAHAN PARA SA EDUKASYON SA PAGPAPAHALAGA (PSEP, INC.)

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Elementary and Secondary Schools

1. The Pambansang Samahan Para sa Edukasyon sa Pagpapahalaga (PSEP Inc.) will hold its 19th Annual Convention on November 25-27, 2009 at Brentwood Apartelle, Brentwood Village, Barangay M. Roxas, Baguio City with the theme "Pagpapatibay ng Pagkataong Pilipino: Tugon sa Hamon ng Panahon".

2. The convention aims to:

- a. gain insights in crisis management; learn new social skills in life-like situations to enable one to meet the demands and challenges of the current situation;
- b. recognize and appreciate positive Filipino values as tools towards proactive crisis management as reflected in their concrete programs and actions;
- a. commit oneself and deepen one's responsibilities in carrying out various activities leading to successful crisis management; and
- b. enhance the students' creative participation in the promotion and strengthening of positive Filipino values through different contests.
- 3. The association will also hold its 7th Tagis-Talino and Sayawit sa Edukasyon sa Pagpapahalaga competitions and the 5th On-the-Spot Poster-Making Contest during the convention. Contestants for the Poster-Making are advised to bring their own materials (1/4 illustration board, pencil, eraser, pastel crayons, etc.)
- 4. The 2009 winners of the Search for Outstanding School Based Values Education Program, VE Educator, and Model Kabataang PSEP Organization will also be awarded. The guidelines and nomination form for the Search are enclosed.
- 5. Participants to this convention are Values Education and Makabayan regional, division and district supervisors, principals, head teachers and teachers-in-charge, VE and Makabayan department heads, coordinators and teachers both in elementary and secondary levels, guidance counselors, Christian Living and Character Education teachers, PSEP, MPSEP, KPSEP

national and local officers and members, PTCA officers and members, students and other interested parties.

- 6. A registration fee of Five Thousand Five Hundred Pesos (Php5,500.00) shall be charged each PSEP participant and Five Thousand Pesos (Php5,000.00) each KPSEP participant. The fee is inclusive of board and lodging, convention materials, honoraria for resource persons and membership fees (for PSEP participants only).
- 7. Regional directors, schools division/city superintendents and school principals are encouraged to send participants to the convention and contests. The regional and division VE/Makabayan supervisors and coordinators shall undertake the coordination in the field pertaining to their respective delegation and representation.
- 8. The PSEP national officers and organizing committee member are allowed to travel two (2) days in advance to attend the preliminary preparation for the convention.
- 9. Student-participants to the convention and contest shall be given enough time to prepare for the quizzes and other examinations which they may have missed because of their absences. They shall be allowed reasonable time to comply with the requirements of the different subject areas.

Contest Mechanics for Tagis -Talino, Sayawit, & Poster-Making

- 1. Contestants must be registered Kabataang PSEP (KPSEP) members at the national level.
- 2. Each division could send at least one to three (1-3) competing teams (Tagis-Talino), performing groups (Sayawit), and 3 participants (On-the-Spot Poster-Making).
- 3. In case there are more than three teams in a division, elimination should be done to meet mechanics #2. Participants coming from the state universities and local colleges are considered national contestants need not participate in the division elimination.
- 4. Each competing school should submit to the PSEP Inc. Secretariat a certification duly signed by the school principal/head bearing the names of the contestants and their alternates, and the name of the trainers/coaches with their full mailing address and contact numbers ON or BEFORE November 5, 2009.

Rules of the Contest - TAGIS-TALINO

- 1. The teams will compete in the Easy (1pt.), Average (3pts.), and Difficult (5pts.) categories.
- 2. There will be 10 questions per category that relate to the contents of Values Education I-IV.
- 3. The quizmaster will read the questions twice and the team will be given 15 seconds to write the answer on the flash card then wait for the quizmaster's signal to raise their answers. The scorers will check the answers and tally the scores on the scoreboard.
- 4. The three teams with the highest scores will be declared as winners. (Champion, 1st runner up, and 2nd runner up)
- 5. In case of a tie, the quizmaster will ask another three questions. The team with the highest core will automatically be declared as the winner.
- 6. Cash prizes and trophies await the winner.

Rules of the Contest - SAYAWIT

- 1. Sayawit presentation must be relevant to the congress theme.
- 2. Presentation time should not exceed 10 minutes including entrance, exit, and other preparations for stage.
- 3. Number of participants should be from 7-10. (Singers and dancers, excluding technical assistants, who are singing and dancing at the same time.)
- 4. Contestants may use props and other stage sets.
- 5. Live accompaniment is required, and no lip-synchs.
- Costumes must be appropriate to the movements.

Criteria for Judging

- 1. Concept and relevance to the theme.
- 2. Choreography and staging
- 3. Musicality
- 4. Props, costumes, and audio visual effects.

Rules of the Contest - ON-THE-SPOT POSTER-MAKING

- 1. Contestants are advised to bring their own materials
 - a. ¼ illustration board;
 - b. Pencil; and
 - c. Pastel / craypass
- 2. Contestants are given 3 hours time allotment to finish work.
- 3. Letterings and boarders are not allowed as a part of the presentation.

Guidelines for Implementation: The search is open to all secondary schools in both public and private duly nominated be their respective division head using the prescribed nomination form.

Award and Prizes

The winner shall receive the following awards and prizes;

- 1. A Plaque of Recognition for the School Awardee and its Division.
- 2. Cash prize of **Php10.000.00** for the winning school.

The awarding ceremony will coincide with the **Values Education Convention** on **November**, **2009**.

Qualification of Nominee

- 1. The school nominee must be presently offering Values Education both as a separate subject area and as integrated in the core subjects for the last three (3) years or more.
- 2. The school nominee must be recommended by the Division. Only one nominee per division will be accepted by PSEP.

Selection Procedure: For the first level. All supporting documents (within the last three (3) years) submitted by the school nominees shall be rated according to a set of criteria presented below: Outstanding Implementation of the Values Education Program -----25% (well-managed VE program, introduced innovations in teaching VE, conducted researches, prepared instructional materials in VE and received awards and recognition) Faculty Professional Development Program -----25% (qualified teaching staff, provided professional development program, attended Values Education training programs, members of PSEP) Student Development Program -----25% (well-organized KPSEP group, supported various students' activities - youth for a, seminar, convention, etc.) Community Involvement and School Leadership -----25% (conducted and participated in community projects and reach out programs, mobilized the community for Values Development) 100%

2. The top three (3) ranking nominees shall be declared as the National Finalists.

- 7. List of Student Activities with supporting documents.
- 8. List of Community Involvement and Leadership with supporting documents.

<u>Guidelines for Implementation</u>: The search is open to all full-time Values Education department heads and teachers in the elementary, secondary, and tertiary schools both public and private duly nominated by their respective school heads and using the prescribed nomination form.

Award and Prizes

The winner shall receive the following awards and prizes;

- 1. A Plaque of Recognition for the Awardee and the school where he/she comes from.
- 2. Cash prize of **Php10.000.00** for each winner in the elementary, secondary, and tertiary levels.

The awarding ceremony will coincide with the **Values Education Convention** on **November**, **2009**.

Oualification of Nominee

- 1. The nominee must be a Filipino citizen, male or female, presently teaching VE, and must have taught Values Education in the elementary, secondary, or tertiary level, whether in public or private school, for three (3) consecutive years or more.
- 2. The nominee for the award must be recommended by the school head.
- 3. The nominee must be of good moral character as certified by the school head.
- 4. The nominee must not be presently an Officer of Board Member of PSEP.
- Nominees and Finalists in the previous year's search (except the winners) are still qualified for re-nomination.

Selection Procedure:

1. For the first level. All supporting documents (within the last three (3) years) submitted by the school nominees shall be rated according to a set of criteria presented below:
