REGIONWIDE NATIONAL ENGLISH PROFICIENCY PROGRAM (NEPP)
ENHANCEMENT TRAINING OF MENTORS ON COMMUNICATIVE LANGUAGE
TEACHING (CLT), ASSESSMENT AND INTERVENTION FOR GRADES I-III
AND GRADES IV-VI TEACHERS/MENTORS

- 1. In pursuance to DepED Memorandum Nos. 107 and 137, s. 2009, the National English Proficiency Program (NEPP) of this Department announces the conduct of the Regionwide Enhancement Training of Mentors on Communicative Language Teaching (CLT), Assessment and Intervention for Grades I-III and Grades IV-VI Teachers/Mentors this Summer 2009.
- 2. The training aims to enhance the teachers'/mentors' knowledge and skills in Communicative Language Teaching (CLT), Assessing Reading, and to provide the necessary interventions.
- 3. The specific dates and venues of the trainings for each region will be determined by the regions thru the Regional NEPP Coordinators.
- 4. The participants to these activities are the elementary school teachers from the identified low performing schools, who were trained on the basic seven-day Reading and Gabay Training for Teachers in 2008.
- 5. The DepED Central Office will provide for the board and lodging and training kits of the participants while their transportation expenses will be charged to local funds.
- 6. Expenses for this activity such as board and lodging of the participants, transportation expenses and other related expenses of the Regional Trainees, Regional Technical Writing Group (TWG), National Supervising Team and staff, training kits, supplies and other incidental expenses shall be charged against NEPP funds subject to the usual accounting and auditing rules and regulations.
- 7. The NEPP Regional Coordinators are requested to submit the following documents: a) budget proposal, and b) bidding documents for the venue. Likewise, they are required to submit a training completion report after the training.
