TREE-PLANTING, TREE-GROWING AND TREE-CARING PROGRAM STRATEGIC PLANNING CONFERENCE AND WORKSHOP

- 1. - 5. Travel and other incidental expenses of participants from DepED Regional Offices shall be charged against local funds. Expenses for food and accommodation, supplies and materials and other incidental and necessary expenses, including transportation of DepED Central Office personnel, facilitators and resource persons, shall be shouldered by the DepED-CSCA chargeable against DepED-OSEC funds.
