SEMINAR-WORKSHOP ON STRENGTHENING COOPERATIVES IN THE DEPARTMENT OF EDUCATION

- 1. The Department of Education (DepED), through the Employees Welfare and Benefits Division (EWBD), in coordination with the DepED Office of the Consultant on Cooperatives, will conduct a **Seminar-Workshop on Strengthening Cooperatives in the Department of Education**.
- 2. Generally, this seminar-workshop aims to equip the participants with a working knowledge and skills on the proper management of cooperatives by defining their roles as cooperative leaders. Specifically, it aims to:
 - a. provide the participants with basic management tools and techniques on cooperative management;
 - b. clarify and define the roles of cooperative leaders and enhance their leadership skills;
 - c. identify possible social and economic opportunities suitable to the cooperative; and
 - d. formulate viable plans with specific targets.
- 3. The seminar-workshop will be conducted in each region. However, due to limited funds, the first series will be conducted for participants coming from Regions I, III, CAR and NCR scheduled as follows:

The seminar-workshop in other regions shall be scheduled upon availability of funds.

- 4. Participants to the seminar-workshop are the officers of either a teachers' cooperative or non-teaching employees' cooperative in every division (only one cooperative per division). These officers shall include the Chairperson, Treasurer, one (1) Member of the Board of Directors and Cooperative Manager. Participants shall also include the personnel in-charge of cooperatives in the division and regional offices.
- 5. Resource speakers shall come from the Cooperative Development Authority (CDA), DepED Office of the Consultant on Cooperatives, and successful cooperative practitioners. Facilitators and support staff shall be provided by the EWBD and other offices in the Central Office.
- 6. Expenses to be incurred in this seminar-workshop shall be charged against the funds appropriated in the DepED budget for FY 2009 for the formation of teachers' cooperatives under Item No. A.II.i.3. These expenses shall include board and lodging, supplies and materials, training kits, communication, honorarium of resource speakers and facilitators, contingency and other incidental expenses and travel expenses of the resource speakers and facilitators and the staff from the Central Office. Transportation expenses of participants shall be charged against local funds.
- 7. Enclosed is the schedule of activities for this seminar-workshop.
