8TH ANNUAL CONVENTION OF THE PUBLIC SCHOOLS DISTRICT SUPERVISORS ASSOCIATION (PSDSA)

- 1. The Public Schools District Supervisors Associations (PSDSA) will hold its 8th Annual Convention on August 5-7, 2009 at the Great Eastern Hotel, 1403 Quezon Avenue, Quezon City, Metro Manila with the theme "The District Supervisors' Pro-Active Roles: Discovering the Tipping Points in Breakingthrough Learning Environment".
- 2. The convention aims to:
 - a. enhance capabilities of stakeholders in School-Based Management;
 - b. identify enabling factors in the success of school performance;
 - c. strengthen partnership of stakeholders for quality educational landscape; and
 - d. revisit and retool the district supervisors' personal and professional competencies on National Competency-Based Teacher Standard (NCBTS).
- 3. Authorized to attend this live-in convention on **official business** are all public schools district supervisors, principals in-charge of the district, PTA Federation presidents, and LGU Chair on Education, PTA-PTCA Presidents or their representatives.
- 4. The convention shall be managed by the PSDSA, through the different committees composed of its current officers and Board of Directors. The secretariat shall be composed of selected PSDSA staff. Members of the different committees and the secretariat shall be authorized to travel two (2) days before the convention.
- 5. The registration fee of Five Thousand Five Hundred Pesos (PhP5,500.00) shall be charged each participant and committee member to cover 3 days/2 nights accommodation with meals and snacks, honoraria for resource speakers, materials, handouts, kits, supplies and other related expenses. Payments may be made in cash or check in the name of PSDSA.

- 6. Expenses such as registration fee, transportation and other incidental expenses relative to the convention shall be charged against local/agency funds subject to the usual accounting and auditing rules and regulations.
- 7. The regional presidents are requested to confirm the number of attendees from their regions on or before July 30, 2009.
