

DepED MEMORANDUM No. **399**, s. 2009

TRAINING OF CORE GROUP OF YEAR I TEACHER TRAINERS IN CAREER PATHWAYS IN TECHNOLOGY AND LIVELIHOOD EDUCATION (CP-TLE)

To: Regional Directors
Schools Division/City Superintendents
Heads, Public Secondary Schools

- 1. In preparation for the rollout of the 2010 Secondary Education Curriculum (SEC), this Department through the Bureau of Secondary Education (BSE) shall conduct a two-cluster Training of Core Group of Year I Teacher Trainers in Career Pathways in Technology and Livelihood Education (CP-TLE) on October 20-24, 2009 for Home Economics and Agri-Fishery Arts Components (Cluster I) and on October 26-30, 2009 for Information and Communication Technology (ICT) and Industrial Arts Components (Cluster II) at the Central Luzon State University, Science City of Muñoz, Nueva Ecija.
- 2. The training aims to develop the capacity of a core group of trainers that will prepare teachers for the implementation of the curriculum.
- 3. The regional delegation shall be composed of two (2) teachers in Agri-Fishery Arts; three (3) teachers in Home Economics; four (4) teachers in Industrial Arts and two (2) teachers in Information and Communication Technology (ICT). The participants must be specialists/major in the area represented, must possess facilitation skills, with leadership potential, must be first year teacher preferably from pilot schools of CP-TLE, best performing schools and other schools offering strong TLE trade courses.
- 4. Traveling expenses and per diems of the participants to and from the training venue shall be cost-shared among the regional and division offices and the schools, chargeable against their respective local funds. However, board and lodging, traveling expenses of the management staff, supplies and materials, honoraria of resource persons and writer-facilitators and other incidental expenses shall be charged against BSE funds, subject to the usual accounting and auditing rules and regulations.
- 5. Participants are advised to avail of the cheapest means of transportation and must report to the training venue on October 19 (Cluster I) and October 25, 2009 (Cluster II) at 6:00 p.m. First meal is dinner of October 19 (Cluster I) and October 25, 2009 (Cluster II) while last meal is lunch of October 24 (Cluster I) and October 30, 2009 (Cluster II).
- 6. The regional office is requested to transmit the list of the regional first year TLE teacher trainer-participants to the Bureau of Secondary Education (BSE) on or before September 30, 2009.
