9<sup>TH</sup> ANNUAL CONVENTION OF THE NATIONAL ORGANIZATION  
OF PROFESSIONAL TEACHERS, INC. (NOPTI)

1. The National Organization of Professional Teachers, Inc. (NOPTI) will hold its 9<sup>th</sup> Annual Convention at Teachers Camp, Baguio City from November 30 to December 1, 2009 with the theme "NOPTI: Strong Leadership Towards National Unity and Progress".
