DEBRIEFING AND EVALUATION OF THE REGIONWIDE ENHANCEMENT TRAINING OF TRAINERS AND PLANNING FOR THE PROGRAM EXPANSION OF THE NATIONAL ENGLISH PROFICIENCY PROGRAM

- 1. The National English Proficiency Program (NEPP) on its third year of implementation for the Elementary Level, with the goal of improving the English proficiency of the public school teachers, this Department announces the conduct of Debriefing and Evaluation of the Regionwide Enhancement Training of Trainers on Communicative Language Teaching (CLT), Assessment and Intervention for Grades I-III and for Grades IV-VI Teachers and the Planning for the Program Expansion on November 12-14, 2009. The venue will be announced later.
- 2. The training programs aim to:
 - a. share/evaluate issues and concerns regarding the conduct of the Regionwide Enhancement Training;
 - b. enhance regional trainers and mentors on the knowledge and skills in facilitating a training for effective transfer of human technology;
 - c. strengthen their interest in advancing proficiency in the English language and sustain further the school-based mentoring program;
 - d. prepare the regional trainers on the conduct of the regionwide training on the basic language and "Gabay" training as an expansion of the program to another one hundred (100) Grades I-III and one hundred (100) Grades IV-VI teachers; and
 - e. sustain school-based mentoring program by providing each elementary school with teachers/mentors.
- 3. The participants to the three-day evaluation and planning activities will be the NEPP Regional Coordinators and one (1) Regional Lead Trainer of Grades I-III and Grades IV-VI or a total of three (3) participants per region.
- 4. The expenses for said activities which include board and lodging, transportation expenses, conference kit with handouts, supplies and materials, shall be charged against NEPP funds subject to the usual accounting and auditing rules and regulations.

- 5. The participants will reimburse their transportation expenses from NEPP Funds upon submission of travel documents. They are advised to take the cheapest mode of transportation.
- 6. Enclosed is the confirmation form to be submitted on or before November 10, 2009.
- 7. Relative to the aforementioned activities is the Search for Outstanding Teacher-Mentors as announced in DepED Memorandum No. 89, s. 2009. The deadline for submission of nominees will be during the Debriefing on October 1-3, 1009.
