REGIONWIDE NATIONAL ENGLISH PROFICIENCY PROGRAM (NEPP) TRAINING ON ENGLISH LANGUAGE AND "GABAY" TRAINING PROGRAM FOR GRADES I-III AND GRADES IV-VI TEACHERS/MENTORS

- 1. In pursuance to DepED Memorandum Nos. 107 and 137, s. 2009, the National English Proficiency Program (NEPP) of this Department announces the conduct of the Regionwide Training on English Language and "Gabay" Training for Grades I-III Teachers/Mentors.
- 2. The training aims to expand the program to the Academically Challenged Schools and the schools which do not have mentors in respond to the program's aim of providing each elementary school with two (2) mentors (one for Grades I-III and one for Grades IV-VI teachers).
- 3. The specific dates and venues of the trainings for each region will be determined by the regions thru the Regional NEPP Coordinators.
- 4. The participants to these activities are the Elementary School Teachers from the identified Academically Challenged Schools, and from schools which do not have mentors.
- 5. The DepED Central Office will provide the board and lodging, training kits and training materials of the participants while their transportation expenses will be charged to local funds.
- 6. Expenses for said activities such as board and lodging of the participants, transportation expenses and other related expenses of the Regional Trainers, Regional Technical Working Group (TWG), National Supervising Team and staff, training kits, supplies and other incidental expenses shall be charged against NEPP-HRTD (Human Resource and Training Development) funds subject to the usual accounting and auditing rules and regulations.
- 7. The NEPP Regional Coordinators are requested to submit the following documents: a) budget proposal; and b) bidding documents for the venue. Likewise, they are required to submit a training report after the training.
