### NATIONAL FEDERATION OF SUPREME STUDENT GOVERNMENTS (NFSSG) CONFERENCE

To: Regional Directors
Schools Division/City Superintendents
Heads, Public and Private Secondary Schools

- 1. The Department of Education-Center for Students and Co-Curricular Affairs (DepEd-CSCA) will conduct the National Federation of Supreme Student Governments (NFSSG) Conference on November 26-30, 2009 at the Gardens of Malasag, Eco-Tourism Village, Cugman, Cagayan de Oro City.
- 2. As a ready mechanism for student consultations and as a source of policy recommendations, the NFSSG Conference aims to achieve the following:
  - a. Evaluate, identify and resolve issues pertinent to the mid-year implementation of the Student Government Program (SGP) based on its mandated thrusts and activities, the Revised Constitution and By-Laws of the Supreme Student Governments and the conduct of the 7th National Leadership Training for Student Government Officers (NLTSGO);
  - b. Evaluate the impact and gather feedback on the implementation of DepED Order No. 54, s. 2009 (Revised Guidelines Governing Parents-Teachers Associations at the School Level) and DepED Order No. 92, s. 2009 (Revised Guidelines on the Selection of Honor Pupils and Students in Public Elementary and Secondary Schools);
  - c. Consult on other possible SSG-related DepED issuances such as the following:
    - 1. Inclusion of the SSG/SPG President, SSG/SPG Vice President, and the Editor-in-Chief of the Student Publication and the PTA Board of Directors as Observers;
    - 2. Constitution and By-Laws of the Federations of Supreme Student Governments;
    - 3. Guidelines on the Synchronized Elections of School-Based Co-Curricular Organizations;
    - 4. Supreme Student Governments Awards;
    - 5. Election Code of the Supreme Student Governments; and,
    - 6. Constitution and By-Laws of the Supreme Pupil Government.
  - d. Update on the implementation of the Peer Counseling Program in Schools and other projects which harness the student government as an effective partner in achieving quality education and academic excellence in schools;

- e. Assist the newly-elected officers of the National Federation of Supreme Student Governments in the implementation of programs and projects; and
- f. Improve efforts in making available real exposure, experience and learning in responsible and participative democracy and leadership.
- Participants to this conference are the newly-elected Officers of the National Federation of Supreme Student Governments (NFSSG) for School Year 2009-2010, Araling Panlipunan Regional Supervisors/Student Government Program Regional Coordinators, representatives of the Supreme Student Government (SSG) Teacher-Advisers, former NFSSG officers as resource persons and facilitators and DepEd-CSCA personnel.
- Participants are expected to be at the venue in time for lunch on November 26, 2009 until breakfast of November 30, 2009. The members of the DepEd-CSCA staff are authorized to travel one (1) day before and one (1) day after the conference.
- Travel expenses and other incidental expenses of Araling Panlipunan Regional Supervisors/Student Government Program Regional Coordinators shall be charged against local funds and other sources subject to the usual accounting and auditing rules and regulations. Expenses for board and lodging, supplies and materials of all participants, including transportation and other incidental expenses of the former and newly-elected NFSSG Officers, CSCA staff, resource persons and facilitators shall be charged against DepEd Central Office funds.
