SECOND NAPSSPHIL PRINCIPALS CONGRESS

1. The National Association of Public Secondary Schools of the Philippines (NAPSSPHIL), Inc. in coordination with the Bureau of Secondary Education (BSE) announces the holding of the **Second NAPSSPHIL Principals Congress** with the theme "*New Challenges... New Beginning... New Hopes (Renewing Our Faith in Philippine Education)*" at the Legend Hotel and Convention Center, Puerto Princesa City, Palawan on January 20-22, 2010.
2. The congress aims to:
  - a. prepare secondary schools for the implementation of the 2010 Secondary Education Curriculum;
  - b. update the secondary school principals on the Department of Education Performance Evaluation System; and
  - c. provide a forum for principals to assess the level of implementation of school-based management in their respective schools.
3. The participants to this live-out congress are the public secondary school principals, secondary school head teachers/department heads, officers of the NAPSSPHIL and the vocational school administrators/principals. The assistant schools division superintendents in-charge of secondary schools, the chiefs of the regional secondary education divisions and the principals of private schools may attend at their option. Attendance of the public school participants including the working committee members shall be **on official business**.

A registration fee of Four Thousand Five Hundred Pesos (PhP4,500.00) per participant, including working committee members shall be charged to cover three (3) meals (lunch) and five (5) snacks (a.m./p.m.), environmental tour at the underground river, materials and other related congress expenses. Members of the different committees, as well as the present NAPSSPHIL officers and board of directors are authorized to travel two (2) days before the congress. Traveling expenses and registration fee shall be charged against local funds, subject to its availability and the usual accounting and auditing rules and regulations.
