- 1. For the information and guidance of all concerned, the Department of Trade and Industry (DTI) advises all government offices to purchase and/or use only sets of Christmas lights that bear the Philippine Standard (PS) and Import Commodity Clearances (ICC) marks.
- 2. Without the ICC marks, the set of Christmas lights poses danger to users because it may bring electric shock and overheating that leads to fire and loss of properties and lives.
- 3. To properly guide the consumers, the list of brands with ICC marks is enclosed.
