IN-COUNTRY TRAINING PROGRAMME ON MANAGING TEACHING AND LEARNING THROUGH ICT

In support to the present thrust of the Department in the implementation of the ICT4E Program and as part of the continuing provision for relevant professional development programs that prepare ICT-competent teaching and non-teaching staff, the DepEd, in coordination with SEAMEO VOCTECH will conduct an in-country training programme on "Managing Teaching and Learning Through ICT" by cluster on the following dates and venues:

- 2. The following will attend this training program:
 - a. TVE Department Head Teachers of the Top 3 Regional ICT Tech-Voc High Schools; and
 - b. 16 Regional ICT Coordinators
- 3. The participants are highly encouraged to bring their own laptops as the course program will involve hands-on workshops, installation of software and the use of Open Source.
- 4. They are expected to be at the venue a day before the start of the training. First meal to be served is dinner of February 21 (first cluster) and February 28 (second cluster).
- 5. Board and lodging expenses, honoraria, travel and per diem of the facilitators, ICT resource persons, project directors/coordinators and project staff, supplies, function room rental, contingency and other incidental expenses are chargeable against Tech-Voc Funds while transportation expenses of the participants are chargeable against local funds subject to the usual accounting and auditing rules and regulations.
