**NATIONAL SEMINAR AND ORIENTATION ON SCHOOL-BASED MANAGEMENT
(SBM) AND FORMULATION AND REVISION OF MANUAL OF REGULATIONS
FOR PRIVATE SCHOOLS**

1. In line with Republic Act No. 9155 on the Governance of Basic Education Act which sets the overall direction of the Department of Education towards the implementation of School-Based Management (SBM) and with the need to come out with the Revised Manual of Regulations for Private Schools, the Association of the Private Schools of the Philippines, in coordination with the Department of Education (DepEd) will hold a National Seminar and Orientation on School-Based Management (SBM) and Formulation and Revision of Manual of Regulations for Private Schools on January 8-9, 2010 at Sarabia Manor Hotel and Convention Center, Gen. Luna Street, Iloilo City.
