ADDITIONAL INFORMATION AND CHANGES TO DEPED MEMORANDUM NO. 528, S. 2009  
(First Philippine Conference Workshop on Mother Tongue-Based Multilingual Education)

To: Regional Directors  
Schools Division/City Superintendents  
Heads, Public and Private Elementary and Secondary schools  
All Others Concerned

1. The following are additional information to DepEd Memorandum No. 528, s. 2009:

a. The conference workshop is designed as an in-service training (INSET) opportunity for teachers of all subjects, administrators, curriculum and materials developers, subject area specialists, and other education stakeholders;

b. Each regional director is enjoined to send at least ten (10) representatives and should include personnel with the following qualifications:

1. Teachers who are capable and ready to teach in the mother tongue;
2. Personnel who are able to design instructional materials in the mother tongue;
3. Personnel who have the technical knowledge in local languages and can lead the formulation of local orthographies;
4. Personnel who are able to lead advocacy and mobilization for the use of the mother tongue based multilingual education; and
5. The delegates are the potential members to comprise the MLE Technical Working Group (TWG) and MLE trainers pool as specified in DepED Order No. 74, s. 2009.

c. An exhibit booth will be prepared for each region to display the following:

1. Local instructional materials made in the local language;
2. Literature written and produced by local writers;
3. Dictionaries, primer, and other materials written about local languages in the region;
4. Artifacts and local crafts displaying the unique features of the local culture; and
5. A local language map.



d. Summary of studies/experiments made related to MLE can be submitted to conference organizers (through email [mlephilippines@gmail.com](mailto:mlephilippines@gmail.com)) on or before January 15, 2010. They will be featured either during parallel paper presentations or through a poster presentation; and

e. Each participant shall be responsible for arranging his or her own lodging and accommodation throughout the conference-workshop. Local hotels would charge between Two Thousand Five Hundred Pesos-Three Thousand Five Hundred Pesos (PhP2,500.00-PhP3,500.00) for the whole duration of the conference.

2. The following are changes to said DepEd Memorandum:

a. A ten percent (10%) discount shall be offered for those who will register on or before January 31, 2010; and

b. Conference fees, travel expenses and other incidental expenses shall be charged against MOOE or other available school/local funds subject to its availability and the usual accounting and auditing rules and regulations. Participants from the private schools shall make their own financial arrangements with their respective schools or sponsoring institutions.
