GUIDELINES FOR THE UTILIZATION OF DOWNLOADED FUNDS IN SUPPORT TO THE IMPLEMENTATION OF THE EVERY CHILD A READER PROGRAM

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Heads, Public Elementary Schools

- 1. The Bureau of Elementary Education (BEE) through the Staff Development Division (SDD) is downloading funds in the total amount of Five Million Four Hundred Twelve Thousand Pesos (PhP5,412,000.00) for assistance to the regions in the implementation of various projects and activities of the "Every Child A Reader Program (ECARP)". Fund allocation varies depending on the number of divisions and schools per region. Specific allocation per region is found in Enclosure No. 1.
- 2. Specifically, the downloaded funds shall be used for the following ECARP activities:
 - a. Printing of the new set of Phil-IRI assessment tools for SY 2010-2011 to be distributed to the divisions and schools (Master copy from the central office will be distributed to the regions and divisions);
 - b. Training on the Utilization of Phil-IRI Database System and other related trainings;
 - c. Division-initiated reading intervention projects/activities;
 - d. Implementation of the Reading Recovery in the pilot division/s in National Capital Region (NCR), Regions V, VI, and XI; and
 - e. Monitoring and technical assistance by the divisions and regions.
- 3. The regions shall be accountable for the disbursement of the downloaded funds and proper liquidation at their own organizational levels subject to the usual accounting and auditing procedures.
- 4. The BEE shall monitor the utilization of funds and will oblige the regions to submit a consolidated regional report using the format in Enclosure No. 2. It is also reiterated that Phil-IRI data be submitted using the Phil-IRI database system. To access and view reports, please log-on to the official Phil-IRI website: www.phil-iri.com.
