NATIONAL ORIENTATION AND SEMINAR-WORKSHOP ON THE FORMULATION AND REVISION OF MANUAL OF REGULATIONS FOR PRIVATE SCHOOLS

Participants to this live-out seminar-workshop in each cluster are Schools Division Superintendents, Legal Officers, Administrative Officers, Pre-Elementary, Elementary and Secondary School Principals/Administrators, Education Supervisors in-Charge of Private Schools, School Owners of Private Schools and Regional and Division School-Based Management (SBM) Coordinators.
- 4. A registration fee of One Thousand Five Hundred Pesos (PhP1,500.00) shall be charged each participant to cover materials and other related seminar expenses. Meals to be served include two (2) lunch and three (3) snacks (a.m./p.m.). Registration fee and other traveling and incidental expenses shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations.
