1. The schedule of the three (3) phases of the "Husay ng Batang Pinoy 2009" Paper Clay Art Competition to be conducted by JNBM Amazing Arts Philippines, Inc. in cooperation with the Department of Education (DepEd) through the Culture and Arts Office (CAO) as stated in DepEd Memorandum Nos. 412 and 507, s. 2009 have been changed as follows:

Phase 1	Division Level	March 12, 2010
Phase 2	Regional Level	March 15-19, 2010
Phase 3	National Grand Awarding	March 26, 2010

- 2. The division coordinator must submit the winning entries of the first place winners only (elementary and high school) to the regional coordinator, who in turn, will submit to JNBM Amazing Arts Philippines at Stall 131, Bldg. I, Mangosteen Road, FTI Complex, Taguig City. They are also required to include the list of division winners with complete name, address, birthday, school, grade or year level, section and teacher/adviser and division or region.
- 3. Prizes for all the winners in all levels (division, regional and national) will be released during the Grand Awarding Ceremony to the regional coordinator.
- 4. All regional coordinators and all the regional first place winners (1 elementary and 1 secondary) are invited to attend the Grand Awarding Ceremony to be held in Manila Ocean Park on March 26, 2010. The program will start at 3:00 p.m. Food (snacks and dinner) will be provided to them. The winners may be accompanied by one parent or guardian at their own expense.
- 5. Travel expenses of the regional coordinators and regional winners (specified in Item 4), may be charged to local funds or any other sources subject to its availability and the usual accounting and auditing rules and regulations.
- 6. The DepEd Culture and the Arts Office (CAO) shall coordinate and monitor the National Awarding. Travel and other allowable expenses to be incurred in connection with this activity shall be charged to OSEC funds.
