**ORIENTATION AND SEMINAR-WORKSHOP ON THE REVISION
OF MANUAL OF REGULATIONS FOR PRIVATE SCHOOLS**

2. The objective of this activity is to revisit, review and improve the existing Manual of Regulations for Private Schools.


