
DepEd MEMORANDUM

TRAINING-WORKSHOP FOR TEACHERS, COORDINATORS AND ADMINISTRATORS
OF PRIVATE SCHOOLS ON THE IMPLEMENTATION OF THE 2010
SECONDARY EDUCATION CURRICULUM

1. The Private Secondary School Administrators Association of the Philippines (PRISSAAP), in coordination with the Department of Education - Bureau of Secondary Education (DepEd-BSE) will conduct the Training-Workshop for Teachers, Coordinators and Administrators of Private Schools for all subject areas in preparation for the implementation of the 2010 Secondary Education Curriculum for the first year level on March 19-21, 2010 at Teachers Camp, Baguio City.
2. The seminar aims to:
 - a. orient teachers on the salient features and core elements of the curriculum;
 - b. equip teachers with skills in designing instructional/learning plans; and
 - c. provide opportunities for teachers to simulate the implementation of the curriculum in the classroom.
3. The training staff shall be headed by Dr. Lolita M. Andrada, Director IV, Bureau of Secondary Education. The workshops shall be facilitated by the ten (10) subject specialists from the Bureau. For MAPEH, there should be two (2) groups - one (1) for Arts and Music and the other for Physical Education and Health.
4. The participants to the seminar-workshop will come from the private schools.
5. A registration fee of Three Thousand Two Hundred Pesos (PhP3,200.00) inclusive of board and lodging, seminar/kit and handouts will be charged each participant. Schools are requested to send ten (10) teachers and may have one more teacher free of charge for a total of eleven in the group.
