REGIONAL TRAINING ON RESEARCH SKILLS AND DATA ANALYSIS USING STATISTICAL TOOLS FOR REGIONAL AND DIVISION PLANNING UNITS

- 1. The Department of Education (DepEd) through the Staff Development Division-Human Resource Development Service (SDD-HRDS) and Office of the Planning Service (OPS) conducted a three-day Training of Trainors on Research and Statistical Tools for Planning Officers last December 1-3, 2009 at the Girl Scouts of the Philippines (GSP) Tagaytay, Tagaytay City for Regions I, II, III, IV-A, IV-B, V, X, and NCR and CAR and December 8-10, 2009 at the Applied Nutrition Center (ANC), Banilad, Cebu City for Regions VI, VII, VIII, IX, XI, XII, and CARAGA and ARMM. Consequently, there is a need for replicating similar training program for their respective regions and divisions and the monitoring of the said activity by the Central Office representatives as stated in DepEd Memorandum No. 451, s. 2009 dated October 13, 2009.
- 2. The regional training aims to ensure that the planning units in both regions and divisions are capacitated for the planning work they do in their respective offices specifically the skills on research and data analysis using effective research method and statistical tools. This is to raise the level of competencies on research and statistics and to upgrade the quality of research and data management in the field.
- 3. The participants to this regional training program are other planning officers and personnel of the planning units who are responsible for educational planning and managing statistical data and handling critical information for decision making in their offices. The enclosed schedules of regional trainings are directly given by the regions themselves. Participants should be directly working for/in the planning unit.
- 4. Travel and per diem of participants are chargeable against local funds while training subsidy will cover the board of the participants and board and lodging of program monitors, travel and per diem of facilitators, resource persons and program monitors, training package cost, supplies, honoraria of external resource persons and facilitators and program monitors. Contingency funds are chargeable against Human Resource Training and Development (HRTD) Funds, subject to the usual accounting and auditing rules and regulations. The training subsidy will be disbursed by the Special Disbursing Officer from the Central Office. Process observers/monitors from the Central Office will also be in the venues to oversee the training and may serve as resource persons for some topics. The regional training



teams will submit reports right after the activity to be incorporated in the report of the monitors/process observers.

5. Immediate and wide dissemination of this Memorandum is desired.
