SEMINAR-WORKSHOP FOR LIBRARIANS AND GUIDANCE COUNSELORS (BATCH II)

- 1. The National Association of Secondary Schools of the Philippines (NASSPHIL), in coordination with the Bureau of Secondary Education Department of Education (BSE-DepEd) will hold the Seminar-Workshop for Librarians and Guidance Counselors (Batch II) on May 20-22, 2010 at Ecotech Center, Lahug, Cebu City.
- 2. The seminar-workshop aims to:
 - a. upgrade the competence and improve the efficiency of librarians and guidance counselors;
 - b. provide opportunities for librarians and guidance counselors in Basic Education to do linkaging and networking; and
 - c. familiarize them with indexing policies, guidelines and procedures particularly for those who are not bachelors degree holders in library science.
- 3. The participants to this seminar-workshop are librarians and guidance counselors from both public and private secondary schools who were not able to attend the first batch held at El Grande Hotel, Alta Tierra, Tabuk Suba, Iloilo City, last February 21-23, 2010.
- 4. A registration fee of Three Thousand Two Hundred Pesos (PhP3,200.00) will be charged each participant to cover board and lodging, handouts and other incidental expenses. First meal shall be a.m. snacks on May 20 and last meal shall be lunch on May 22, 2010. Traveling expenses and registration fee will be charged to local school funds subject to the usual accounting and auditing rules and regulations.
- 5. Participants are expected to arrive at the venue on the day before the start of the seminar-workshop. Participants from private and public schools are urged to arrive at the seminar-workshop punctually on the scheduled dates.
