DepEd MEMORANDUM No. 134, s. 2010

THIRD NATIONAL CONVENTION OF THE CENTERS OF EXCELLENCE (COEs), CENTERS OF DEVELOPMENT (CODs), CENTERS OF TRAININGS (COTs) AND LOCAL COLLEGES AND UNIVERSITIES (LCUs)

- 1. The Teacher Education Council (TEC) of the Department of Education (DepEd), in coordination with the Commission on Higher Education (CHED), will conduct its Third National Convention of the Centers of Excellence (COEs), Centers of Development (CODs), Centers of Training (COTs) and Local Colleges and Universities (LCUs) on April 28-29, 2010 at the Mimosa Villas, Clark, Pampanga.
- 2. The theme of the convention is "Bridging DepEd Thrusts with Teacher Education Programs". Enclosed is the program of activities.
- 3. The activity aims to:
 - a. orient the participants on the National Competency-Based Teacher Standards-Basic Education Sector Reform Agenda (NCBTS-BESRA) for Teacher Development Program (TDP) for Multi-Lingual Education (MLE);
 - b. underscore the roles and responsibilities of COTs in the implementation of the current thrusts of DepEd;
 - c. discuss curricular issues and concerns relative to CHED Memorandum Order (CMO) No. 30, s. 2004; and
 - d. enhance the training design for the Teacher Induction Program (TIP) in English, Science and Mathematics incorporating current topics on MLE, Education for Sustainable Development (ESD) and Understanding by Design (UbD).
- 4. Participants to the conference are the Deans of the Colleges of Education, the Student-Teaching Supervisors of COEs, CODs, COTs and LCUs; the Schools Division Superintendents (SDSs) in the Divisions where the Teacher Education Institutions (TEIs) are located; and the DepEd and CHED Regional Directors. The Deans of the Colleges of Education shall be duly authorized by CHED.



- 5. All expenses relative to board and lodging of the participants, TEC-DepEd resource speakers, training staff and facilitators, including supplies and materials, professional fees of resource speakers shall be charged against the TEC-OSEC proper funds. First meal is lunch on April 28, 2010 (Wednesday) and the last meal is p.m. snacks on April 29, 2010 (Thursday).
- 6. Traveling expenses of resource speakers and training staff shall be charged against TEC-OSEC proper funds, while the travel expenses of DepEd participants shall be charged against the local INSET fund. Travel expenses of COEs, CODs, COTs and LCUs participants shall be funded by their institutions.
- 7. Participants are requested to bring their laptops. COTs that have provided the TIP for the DepEd teachers are requested to bring their TIP Training Design.
