**TRAINING-WORKSHOP ON THE SPECIAL PROGRAM IN SPORTS (SPS)**

1. The Bureau of Secondary Education (BSE) will conduct the Training-Workshop on the Special Program in Sports (SPS) at the Teachers Camp, Baguio City on May 3-7, 2010.
2. The training aims to update the SPS implementers on the Physical Education component of the secondary education curriculum, develop the program outline, and continuously build the capacity and capability of the teacher-implementers of the SPS lead schools to improve student performance.
3. The participants to this training are one (1) Regional Sports Supervisor, one (1) Division Sports Coordinator, School Heads and teachers of the seventeen (17) lead SPS schools and those schools implementing the program. Participants must have the knowledge and skills in the following sports events: athletics, badminton, basketball, baseball, chess, football, gymnastics, sepak takraw, softball, swimming, table tennis, taekwondo, tennis and volleyball.
4. A registration fee of Five Thousand Pesos (PhP5,000.00) shall be charged each participant to cover board and lodging, rentals of sports facilities and equipment, training kit, transportation of participants to and from the practicum venue, honoraria of training staff and other incidental expenses relative to the training. Registration fee and traveling expenses of participants shall be charged against local funds, while traveling expenses, board and lodging and other incidental expenses of resource persons and BSE staff shall be charged against BSE funds. All expenses are subject to the usual accounting and auditing rules and regulations.
4. Registration will start on May 2, 2010 at 1:30 p.m. at the venue. First meal will be dinner on May 2, 2010 and the last meal will be lunch on May 7, 2010.
